Contributions are voluntary and a member's rights are not affected nor will a member be favored or disadvantaged by reason of the amount of the contribution or a decision not to contribute. The Iowa Corn Growers Association PAC must use its best effort to obtain name, address, occupation, and employer for all contributors over \$200. A six-member bipartisan committee of ICGA farmer-members administers the PAC fund.
